OBJECTIF

L'objectif de ce rapport est de montrer comment, dans le monde entier, des millions de personnes sont mortes et des centaines de millions d'événements indésirables graves se sont produits après des injections de la thérapie génique expérimentale à ARNm. FAITS

DANS LE MONDE ENTIER

Bien que ce rapport se concentre sur la situation aux États-Unis, il s'applique également au reste du monde, car le même type d'injections expérimentales avec des taux de mortalité similaires - et des systèmes de corruption comparables pour cacher ces chiffres - est utilisé dans le monde entier. C'est pourquoi nous encourageons tout le monde dans le monde à partager ce rapport. Puisse-t-il être un signal d'alarme pour l'ensemble de l'humanité.

AU MOINS 5 FOIS PLUS DE MORTS

LES DÉCÈS DUS AUX VACCINS SONT GRAVEMENT SOUS-DÉCLARÉS

Les données VAERS du CDC américain montrent qu'au 26 août 2021, un demi-million de personnes avaient déjà souffert d'effets secondaires graves, notamment d'accidents vasculaires cérébraux, d'insuffisance cardiaque, de caillots sanguins, de troubles cérébraux, de convulsions, de crises d'épilepsie, d'inflammations du cerveau et de la moelle épinière, de réactions allergiques potentiellement mortelles, de maladies auto-immunes, d'arthrite, de fausses couches, d'infertilité, de faiblesse musculaire d'apparition rapide, de surdit , de c cit , de narcolepsie et de cataplexie. Outre le nombre astronomique d'effets secondaires graves, le CDC rapporte qu'environ 16 000 personnes sont mortes apr s avoir re u ces injections exp rimentales. Cependant, selon un d nonciateur du CDC qui a sign  une d claration sous serment, le nombre r el de d c s est au moins cinq fois plus  lev . Voici ce que l'experte en d tection des fraudes dans le domaine de la sant  du CDC, Jane Doe, a d clar  officiellement dans une d claration sous serment (1)

« Au cours des 25 derni res ann es, j'ai d velopp  plus de 100 algorithmes distincts de d tection des fraudes dans le domaine des soins de sant , tant dans le secteur public que dans le secteur priv . (...) Lorsque le vaccin COVID-19 a  t  clairement associ    la mort et au pr judice de patients, j'ai  t  enclin   enqu ter sur la question. J'estime professionnellement que la base de donn es VAERS (Vaccine Adverse Event Reporting System), bien qu'extr mement utile, est sous-d clar e par un facteur prudent d'au moins 5. (...) et j'ai  valu  que les d c s survenus dans les 3 jours suivant la vaccination sont plus  lev s que ceux signal s dans le VAERS par un facteur d'au moins 5. »

Le CDC sous-d clare  galement d'autres  v nements ind sirables, comme les r actions allergiques graves (anaphylaxie). L'Informed Consent Action Network (ICAN) a rapport  qu'une  tude a montr  que le nombre r el d'anaphylaxies est 50   120 fois plus  lev  que ce que pr tendent les CDC. (2, 3) De plus, un chercheur priv  a examin  de pr s la base de donn es VAERS et a essay  de rechercher des num ros d'identification de cas sp cifiques. Il a trouv  d'innombrables exemples o  les dossiers de d c s originaux ont  t  supprim s, et dans certains cas, les num ros ont  t   chang s pour des r actions plus l g res. Il dit :

« Ce que l'analyse de tous les num ros de cas nous dit actuellement, c'est qu'il y a environ 150 000 cas qui manquent, qui  taient l , qui ne sont plus l . La question est de savoir si ce sont tous des d c s. » 4

Le caract re criminel du CDC a  galement  t  r v l  il y a quelques ann es, lorsque des chercheurs ont  tudi  le lien entre les vaccins et l'autisme. Ils ont d couvert qu'il y avait effectivement un lien direct. Alors qu'a fait le CDC ? Tous les chercheurs se sont r unis et une grande poubelle a  t  plac e au milieu de la pi ce. Ils y ont jet  tous les documents qui d montraient le lien entre l'autisme et les vaccins.

Ainsi, les preuves ont été détruites. Par la suite, un article soi-disant "scientifique" a été publié dans Pédiatrie, affirmant que les vaccinations ne causent pas l'autisme. Cependant, un scientifique de premier plan au sein du CDC, William Thompson, a révélé ce crime. Il a publiquement admis :

« J'ai contribué à tromper des millions de personnes sur les effets secondaires négatifs possibles des vaccins. Nous avons menti sur les résultats scientifiques. »(5)

Le pire exemple de méthodologie criminelle utilisée pour dissimuler les décès dus aux vaccins est peut-être le fait incroyable que le CDC ne considère pas qu'une personne est vaccinée avant deux semaines après l'injection. Par conséquent, toute personne qui meurt dans les deux premières semaines suivant l'injection n'est pas considérée comme un décès dû au vaccin, ce qui fausse encore plus les données. (6,7)

MOINS DE 1% EST RAPPORTÉ

UNE ÉTUDE MONTRE QUE LE NOMBRE RÉEL D'ÉVÉNEMENTS INDÉSIRABLES EST 100X PLUS ÉLEVÉ.

Toutes ces informations nous montrent déjà que le nombre d'événements indésirables et de décès est une multitude de ce que l'on dit au public. De même, moins de 1 % des événements indésirables des vaccins sont signalés."

RAISONS DE LA SOUS DECLARATION

LA POPULATION EST INCONSCIENTE ET MAL INFORMÉE

Si moins de 1 % des effets indésirables sont signalés, c'est tout d'abord parce que la grande majorité de la population n'est pas au courant de l'existence de systèmes officiels de notification des effets indésirables des vaccins. Deuxièmement, l'industrie pharmaceutique a mené une guerre médiatique sans relâche au cours des dernières décennies contre tous les experts médicaux qui ont tenté d'informer le public sur les dangers des vaccins. L'une des stratégies déployées est l'injure, et l'étiquette négative "anti-vaxx" qui a été choisie pour faire honte et blâmer tous les scientifiques, médecins et infirmières qui disent la vérité.

En raison de cette campagne criminelle de suppression agressive des données sur les effets indésirables, la majorité de la population ne sait pas que les vaccins peuvent causer le moindre dommage.

Le message que le grand public entend et voit en permanence ne pourrait pas être plus éloigné de la vérité : "Les vaccins sont sûrs et constituent le meilleur moyen de se protéger des maladies". Les milliers de livres, d'études scientifiques et de rapports documentant les effets dévastateurs des vaccins en général ont été supprimés par tous les moyens possibles. Le fait indéniable que les enfants (et les personnes de tous âges, d'ailleurs) sont beaucoup plus malades aujourd'hui que jamais auparavant dans l'histoire, alors qu'ils constituent la population la plus vaccinée de toute l'histoire, est catégoriquement nié.

La propagande généralisée des fabricants de vaccins, qui utilisent les agences gouvernementales comme leur principal carrousel, a simplement dit à l'humanité pendant des décennies que les effets indésirables étaient très rares. Par conséquent, lorsque des personnes vaccinées souffrent d'effets indésirables graves, il ne leur vient même pas à l'esprit que cela pourrait être dû à des injections antérieures, et elles ne le signalent donc pas comme tel.

Pendant la crise mondiale actuelle, les attaques contre les experts médicaux qui mettent en garde contre les vaccins ont atteint un niveau encore plus élevé. Les experts médicaux sont maintenant complètement supprimés de tous les médias sociaux, leurs sites web sont déclassés par Google, des chaînes YouTube entières sont supprimées, beaucoup ont perdu leur emploi, et dans certains pays, des experts médicaux ont été arrêtés, dans une tentative de supprimer la vérité sur les injections expérimentales de covid.

Les scientifiques qui s'expriment contre les vaccins sont même qualifiés de "terroristes nationaux". Tous les moyens sont déployés par le cartel criminel des vaccins pour supprimer la vérité.

En conséquence, d'innombrables professionnels de la santé ont peur de signaler les effets indésirables, ce qui contribue à la sous-déclaration de ces effets secondaires. De plus, la quantité d'informations scientifiques mettant en garde contre ces dangereux agents biologiques, et le nombre d'experts médicaux mettant en garde l'humanité, sont tellement écrasants et presque omniprésents - malgré les tentatives agressives de les faire taire - qu'il est pratiquement impossible pour un professionnel de la santé de ne pas être au moins quelque peu conscient du risque qu'il prend, en administrant une injection non testée modifiant l'ADN, sans même informer ses patients de ce qui est injecté dans leur corps.

S'ils voient ensuite leurs patients souffrir ou mourir, ils ont naturellement peur d'être tenus pour responsables et refusent donc de le signaler.

Enfin, de nombreux professionnels de la santé reçoivent des incitations financières pour promouvoir les vaccins. Au Royaume-Uni par exemple, les infirmières reçoivent £10 par aiguille qu'elles insèrent dans un enfant. C'est là encore une raison pour qu'elles ne signalent pas les événements indésirables.

LES DÉNONCIATEURS DE PROJECT VERITAS

DES MÉDECINS ET DES INFIRMIERS S'EXP EXPRIMENT : "ILS NE FONT PAS D'ÉTAT DE LA SITUATION !

Project Veritas est une organisation journalistique qui dénonce depuis des années le crime et la corruption dans notre monde. Elle reçoit souvent des images vidéo provenant de caméras cachées, qui révèlent ce qui se passe derrière des portes closes. Ils ont été contactés par plusieurs médecins et infirmiers fédéraux, qui ne peuvent plus se taire.

Ils voient un grand nombre de patients arriver avec des effets indésirables graves, comme une insuffisance cardiaque, et ils remarquent que les autorités de leurs hôpitaux ne signalent aucune de ces blessures dues aux vaccins. Le docteur Maria Gonzales, médecin urgentiste du département américain de la santé et des services sociaux, exprime son indignation à ce sujet au Phoenix Indian Medical Center. Elle discute avec un collègue de la manière dont un patient a été vacciné et a souffert d'une insuffisance cardiaque :

« Ils ne vont pas accuser le vaccin. Mais il a l'obligation de le signaler, n'est-ce pas ? Ils ne le signalent pas ! - C'est vrai ! Parce qu'ils veulent l'enfouir sous le tapis. Le gouvernement ne veut pas montrer que le vaccin est un tas de merde. »

Dans une interview avec James O'Keefe de Project Veritas, l'infirmière Jodi O'Malley témoigne :

« J'ai vu des douzaines de personnes arriver avec des effets indésirables. »

Elle ajoute que rien de tout cela n'est signalé. Quand on lui demande si elle n'a pas peur des répercussions pour avoir dit la vérité, elle répond :

« Je n'ai pas peur, car ma foi est en Dieu. C'est le mal au plus haut niveau. »

La vidéo montre également l'infirmière Jodi parlant à un médecin, qui cherche désespérément à briser le silence :

« C'est des conneries. Je suis fatigué de tout ça. Donc ce qu'on va devoir faire, parce qu'on est à l'intérieur... J'y ai réfléchi. - "Et, qu'est-ce qu'on fait ?" "Je ne sais pas, mais il y a tellement de choses que je veux faire exploser. - Tellement de choses. Comment on fait ça ? Tu connais le Projet Veritas ? »

Il y a des milliers de médecins et d'infirmiers comme lui, dont le cœur brûle de s'exprimer, mais qui ont peur. J'ai personnellement été contacté par différents groupes de centaines de professionnels de la santé. - ✓ 150 000 rapports ont été rejetés ou supprimés par le système VAERS.
- ✓ Le nombre réel d'anaphylaxies est 50 à 120 fois plus élevé que ce que prétendent les CDC.
- ✓ Les personnes vaccinées qui meurent dans les deux semaines ne sont pas répertoriées comme des décès dus au vaccin.
- ✓ Moderna a reçu plus de 300 000 rapports d'effets indésirables en seulement trois mois.
- ✓ Le rapport Lazarus montre que seul 1 % des événements indésirables est signalé par le public.
- ✓ La majorité de la population ne connaît pas l'existence de systèmes permettant de signaler les effets indésirables des vaccins.
- ✓ Une censure et une propagande agressives ont fait croire au public que les effets indésirables étaient rares, ce qui fait que les gens ne comprennent pas comment leurs problèmes de santé découlent d'injections passées.
- ✓ La honte et les reproches adressés aux professionnels de la santé qui s'opposent aux vaccins incitent de nombreux membres de la communauté médicale à éviter de signaler les événements indésirables.
- ✓ La crainte d'être tenu pour responsable après avoir administré une injection qui a tué ou handicapé des patients, empêche encore plus le personnel médical de la signaler.
- ✓ Le fait d'avoir accepté des incitations financières pour promouvoir et administrer les vaccins covid empêche également le personnel médical de signaler les effets indésirables.
- ✓ Les fabricants de vaccins motivés par le profit ont toutes les raisons de ne pas signaler les destructions causées par leurs produits expérimentaux non testés.
- ✓ Plus de 250 000 utilisateurs de Facebook commentent les décès et les blessures graves causés par les vaccins.
- ✓ Des infirmières et des médecins témoignent de la façon dont leurs hôpitaux dissimulent les blessures liées aux vaccins.

UN TSUNAMI DE DESTRUCTION

Ces données nous amènent à la conclusion inévitable que le nombre d'événements indésirables liés aux vaccins est beaucoup plus élevé que ce que les rapports officiels admettent. Si, en effet, moins de 1 % des cas sont signalés au CDC, le nombre déjà élevé de 450 000 événements indésirables peut facilement atteindre plusieurs millions pour les seuls États-Unis. Si l'on applique ce chiffre au reste du monde, on constate une vague de destruction effroyable, comme l'humanité n'en a jamais connue auparavant. Et les vaccinations ne font que commencer. Ce qui est encore plus inquiétant, c'est que ce n'est que le tsunami de souffrance à court terme causé par les injections de covid. Bill Gates, le plus grand vendeur de vaccins au monde et l'un des principaux moteurs de la campagne mondiale de vaccination contre le covid, a déclaré dans une interview accordée à la BBC que la plupart des effets indésirables ne se manifestent qu'au bout de deux ans, ce qui explique que le développement des vaccins prenne généralement de nombreuses années. Ces données alarmantes conduisent des experts mondiaux, comme le Dr Luc Montagnier, lauréat du prix Nobel de médecine, à lancer un grave avertissement selon lequel nous sommes actuellement confrontés au plus grand risque de génocide mondial de l'histoire de l'humanité. (1) Même l'inventeur de la technologie ARNm, le Dr Robert Malone, met en garde contre ces injections qui utilisent sa technologie. (2,3) La situation est si grave que l'ancien vice-président et scientifique en chef de Pfizer, le Dr Mike Yeadon, s'est manifesté pour mettre en garde l'humanité contre ces injections extrêmement dangereuses. L'une de ses vidéos les plus connues est intitulée "A Final Warning". (4) Un autre scientifique de renommée mondiale, Geert Vanden Bossche, ancien chef du bureau de développement des vaccins en Allemagne et directeur scientifique d'Univac, risque également son nom et sa carrière en s'élevant courageusement contre l'administration des injections covid. Le développeur du vaccin prévient que les injections peuvent compromettre l'immunité des vaccinés, les rendant vulnérables à chaque nouvelle variante. (5, 6) Des survivants de l'holocauste de la Seconde Guerre mondiale ont écrit à l'Agence européenne des médicaments pour demander l'arrêt des injections, qu'ils considèrent comme un nouvel holocauste. DÉCÈS DUS AU VACCIN DANS LE MONDE

IL EN VA DE MÊME POUR LES NATIONS DU MONDE ENTIER

Il nous serait trop long d'énumérer les données de tous les pays du monde, mais la situation que nous avons décrite en détail à partir des États-Unis illustre suffisamment la destruction causée par ces injections, et la façon dont les agences de santé corrompues et les fabricants de vaccins cachent au public la grande majorité des événements indésirables. Nous évoquerons cependant brièvement d'autres pays, pour prouver que la situation américaine n'est pas unique.

UNION EUROPÉENNE

Dans l'Union européenne (qui ne comprend que 27 des 50 pays européens), les rapports officiels d'EudraVigilance admettent officiellement, au 18 août 2021, qu'environ 22 000 personnes sont mortes et que 2 millions ont subi des effets secondaires, dont 50 % sont graves. (1, 2)

« Elle est qualifiée de "grave" si elle correspond à un événement médical qui entraîne la mort, met la vie en danger, nécessite une hospitalisation, entraîne une autre affection médicalement importante ou la prolongation d'une hospitalisation existante, entraîne un handicap ou une incapacité persistants ou significatifs ou qui constitue une anomalie congénitale ou une malformation de naissance ».

Aux Pays-Bas, l'une des plus petites nations de l'Union européenne, un comité de recherche extraparlamentaire a mis en place une plate-forme permettant aux citoyens de signaler les effets indésirables des vaccins. Il ne s'agit pas d'une initiative du gouvernement et les médias ne lui ont accordé aucune attention. La grande majorité de la population néerlandaise n'est donc pas au courant de son existence. Pourtant, malgré son champ d'influence restreint, cette initiative privée a déjà fait l'objet de rapports faisant état de 1 600 décès et de 1 200 dommages pour la santé, qui ont souvent entraîné une invalidité permanente des personnes concernées. (3) Et si l'ensemble de la population vaccinée connaissait l'existence de cette plateforme et faisait une déclaration ? Et si cette plateforme était également disponible dans les autres pays de l'UE, qui sont beaucoup plus grands que les Pays-Bas ?

ROYAUME-UNI

Peu avant le début de la campagne nationale de vaccination, la MHRA (Medicines and Healthcare Products Regulatory Agency) a publié la demande suivante :

La MHRA recherche de toute urgence un outil logiciel d'intelligence artificielle (IA) pour traiter le volume élevé attendu d'effets indésirables du vaccin Covid-19 et s'assurer qu'aucun détail du texte de l'effet indésirable ne soit oublié. (1)

Le gouvernement britannique a publié un rapport sur la première série d'événements indésirables, notamment des cas de cécité, des accidents vasculaires cérébraux, des fausses couches, des insuffisances cardiaques, des paralysies, des maladies auto-immunes, etc. Peu après la première vague de vaccination, plus de 100 000 événements indésirables ont été signalés, dont 1 260 cas de perte de la vue (y compris la cécité totale). La première partie du rapport fait l'éloge des vaccins comme étant le meilleur moyen de protéger les gens contre le COVID-19, puis continue à montrer l'incroyable destruction que ces vaccins provoquent. L'hypocrisie est époustouflante. (2, 3)

Au Royaume-Uni également, le nombre de fausses couches a augmenté de 366% en seulement six semaines, pour les mères vaccinées. (4) En outre, l'Office britannique des statistiques nationales a révélé par inadvertance que 30 305 personnes sont mortes dans les 21 jours suivant l'injection, au cours des 6 premiers mois de 2021. (5) Et un scientifique britannique ayant 35 ans d'expérience a effectué une analyse approfondie du système britannique de signalement des cartons jaunes et a constaté qu'il n'était pas fiable.

Nous pouvons conclure que le système de signalement par carte jaune peut fournir certaines informations limitées qui peuvent être utiles pour alerter le public britannique sur les effets indésirables possibles des vaccins COVID-19. Cependant, la conception initiale du système comme une entreprise purement descriptive plutôt qu'expérimentale signifie qu'il ne peut pas aborder les véritables questions qui sont d'une importance cruciale pour le public britannique.

Il s'agit de savoir s'il existe des relations de cause à effet entre la vaccination avec les vaccins PF et AZ et des effets indésirables graves tels que le décès, et si oui, quelle est l'ampleur de ces effets". (6)

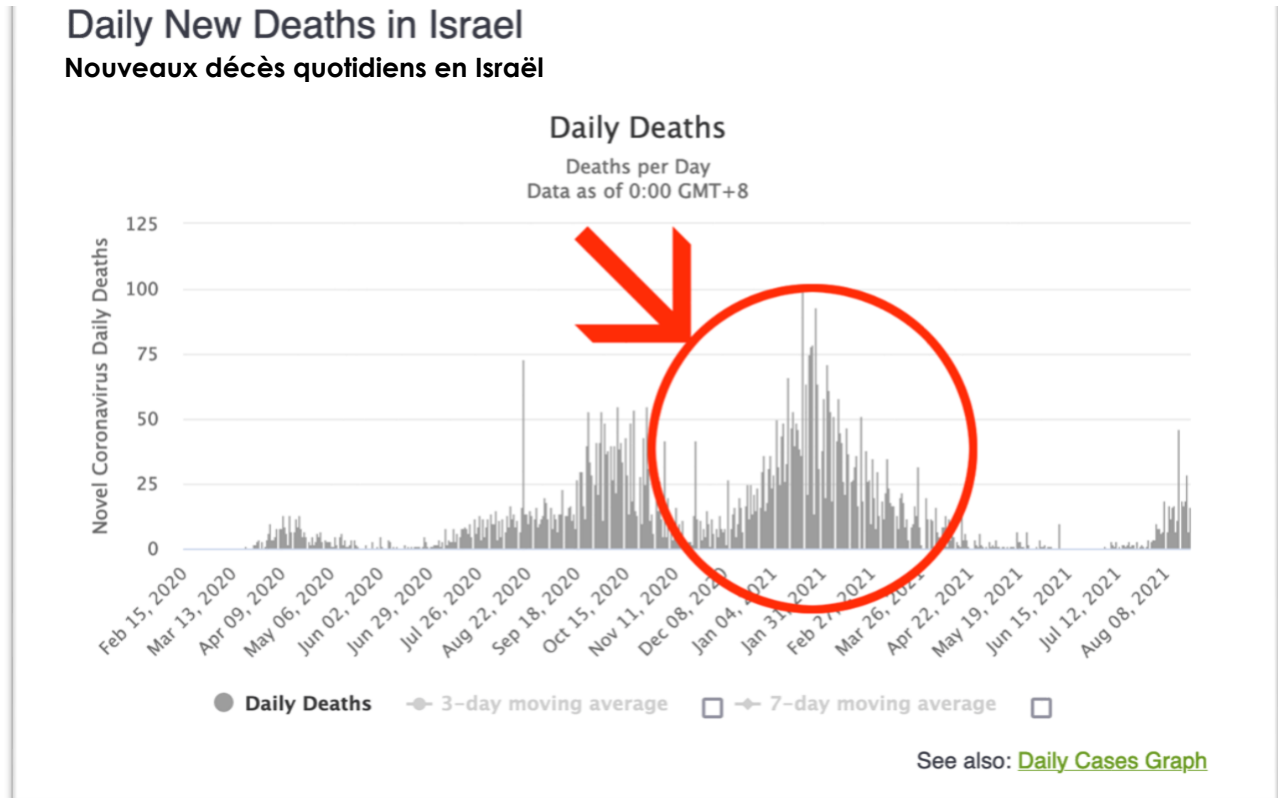

ISRAEL

Le « Israeli Peoples Committee » est une équipe de médecins, d'avocats, de criminologues, d'épidémiologistes et de chercheurs universitaires, déterminée à mener une enquête, une investigation et une exposition au profit du public. Bien qu'il s'agisse d'un groupe relativement peu connu, il a tout de même reçu 3754 rapports, dont plus de 480 décès, en date du 5 août 2021. La CIP affirme que ces chiffres ne représentent que 1 à 3% de la prévalence réelle dans la population, ce qui signifie que, selon ces données, le nombre de décès en Israël est d'environ 48 000 et les événements indésirables d'environ 375 400. Toujours en Israël, les statistiques de Worldometers.info montrent un pic massif de décès lorsque les vaccinations ont commencé. Avant le début de la campagne de vaccination, il n'y avait pratiquement pas de décès quotidiens de covid en Israël. Juste après le lancement du projet de vaccination, le nombre de décès quotidiens est passé de 1 à 3 à 75-100 décès par jour !



Un autre site israélien qui rapporte les blessures causées par les vaccins est [Seethetruth.club/covid-19-vaccinevictims](https://seethetruth.club/covid-19-vaccinevictims) où l'on peut voir d'innombrables témoignages de personnes qui ont beaucoup souffert de l'injection. Aux États-Unis, un site similaire appelé 1000covidstories.com présente un nombre croissant de vidéos de personnes décédées ou ayant eu des réactions graves aux injections de covid. Le site TheCovidWorld.com présente également les histoires personnelles d'un grand nombre de personnes décédées des suites de ces injections. Nous devons comprendre que rien de tel ne s'est jamais produit dans l'histoire, où des milliers de personnes se présentent pour partager leur souffrance suite à une vaccination. La raison pour laquelle les gens agissent ainsi aujourd'hui est que les effets indésirables ne sont pas du tout, comme le disent les agences de "santé" criminelles, des "maux de tête, des vertiges et des symptômes semblables à ceux de la grippe". Les réactions sont extrêmement graves, et handicapent souvent les gens à vie. Les lésions sont en fait si graves que des personnes du monde entier s'avancent pour mettre en garde l'humanité.

BRESIL

Au Brésil, le nombre officiel de décès dus au vaccin est de 32 000 sur une période de 5 mois. Le rapport a été publié sur uol.com.br, qui aurait à peu près le même nombre de pages vues que CNN.com, selon les données de SimilarWeb. Malgré ce nombre élevé de décès suite à une vaccination, le rapport indique que : "La vaccination reste le meilleur moyen de contrôler la maladie".

(5) Plusieurs études prouvent la réalité du renforcement dépendant des anticorps. (6,7,8) L'occurrence de l'infertilité et de la réduction du nombre de spermatozoïdes est également confirmée. (9,10) Enfin, une étude a montré que les injections provoquent le cancer. (11) Et ce ne sont là que quelques exemples...

LES RESPONSABLES DE LA SANTÉ DANS LE MONDE DISENT QU'ILS NE SONT PAS EFFICACES

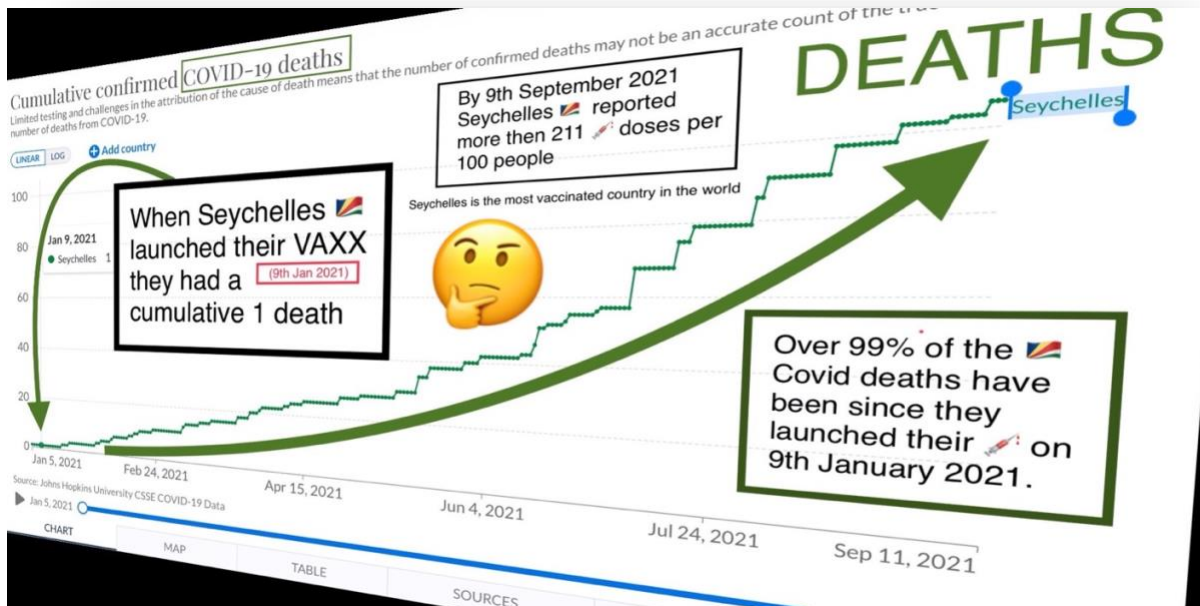
Le concepteur de vaccins de renommée mondiale, Geert Vanden Bossche MVD, PhD, prévient que ces injections détruisent le système immunitaire de l'organisme, rendant les vaccinés vulnérables à chaque nouvelle variante de la maladie (1). Il déclare également :

« Les campagnes de vaccination de masse menées pendant une pandémie de variants hautement infectieux ne parviennent pas à contrôler la transmission virale. Au lieu de contribuer au renforcement de l'immunité de groupe, elles retardent considérablement l'établissement naturel de l'immunité de groupe. C'est pourquoi les campagnes de vaccination universelle en cours sont absolument néfastes pour la santé publique et mondiale. »(1B)

Le Dr Luc Montagnier, prix Nobel de médecine, tire la sonnette d'alarme : ces vaccins créent de nouvelles variantes dangereuses (2) . Et en Israël, les statistiques montrent clairement une augmentation spectaculaire des décès covid après le début des vaccinations (voir plus haut dans ce rapport).

Le Premier ministre israélien, Naftali Bennet, affirme même que les personnes les plus exposées sont celles qui ont reçu deux doses du vaccin. (3)

Dans la nation insulaire des Seychelles, il n'y avait pratiquement aucun décès dû au covid, mais lorsqu'ils ont commencé à vacciner la population, le nombre de décès a été multiplié par cent.



En Australie, un jeune couple s'est vu refuser l'accès à son propre nouveau-né pendant huit jours, alors qu'il était parfaitement vacciné. Le responsable de la santé en Australie, le Dr Jeannette Young, a donné l'explication révélatrice suivante pour cette situation inhumaine : (4)

« Ce n'est pas parce que vous êtes vacciné que vous ne serez pas infecté. C'est pourquoi nous ne pouvons pas autoriser cette famille à rendre visite à son bébé ».

Anthony Fauci a également été très clair : "le CDC envisage de rendre obligatoire le port du masque pour les personnes vaccinées" (5), "les personnes vaccinées sont de plus en plus souvent testées positives au covid, et devront donc continuer à porter des masques" (6) , "les personnes vaccinées doivent toujours éviter de manger dans les restaurants" (7), et "les personnes vaccinées sont autant porteuses de la variante Delta que les personnes non vaccinées" (8) . Ainsi, selon Fauci, les vaccins ne font pratiquement rien. Pourtant, il insiste pour rendre obligatoires ces injections inutiles pour les voyages. (9) Le Premier ministre britannique, Boris Johnson, a déclaré publiquement la même chose : (10)

« Puis-je maintenant rencontrer mes amis et les membres de ma famille à l'intérieur s'ils sont vaccinés ? J'ai bien peur que la réponse soit non, car nous n'en sommes pas encore là, nous en sommes encore au monde où l'on peut rencontrer des amis et des membres de sa famille à l'extérieur, sous la règle des six, ou des deux ménages. Et même si vos amis et les membres de votre famille peuvent être vaccinés, les vaccins ne donnent pas une protection à 100 % et c'est pourquoi nous devons être prudents ».

Un article de recherche publié dans 'Trends in Internal Medicine' par le Dr J. Bar Classen MD, est intitulé : (11)

Les vaccins américains COVID-19 ont prouvé qu'ils causaient plus de mal que de bien sur la base des données des essais cliniques pivots analysées à l'aide du critère scientifique approprié, à savoir "toutes les causes de morbidité grave".

Même le CDC a admis que les injections n'offrent aucune protection contre les variantes Delta, et que les variantes à venir et toutes les mesures coviduelles correspondantes doivent rester en place. (12) Pourtant, ils continuent d'insister sur le fait que tout le monde doit être vacciné. Le responsable de la santé de la Nouvelle-Galles du Sud, en Australie, a déclaré que nous devons nous préparer à vivre avec un cycle constant d'injections de rappel de covid dans un avenir prévisible. (13) Le médecin en chef de Moderna, le Dr Tal Zaks, a déclaré que les vaccins ne ramènent pas la vie à la normale. (14) Ceci a été confirmé par le directeur de l'Organisation mondiale de la santé, Tedros Adhanom, qui a déclaré:15

« Un vaccin ne suffira pas à mettre fin à la pandémie. La surveillance devra se poursuivre, les gens devront toujours être testés, isolés et soignés. Les contacts devront toujours être retrouvés et mis en quarantaine, et les communautés devront toujours être impliquées ».

Une étude de The Lancet a montré que le variant Delta se transmet librement parmi les vaccinés. 16 Cela a été confirmé par une étude qui a montré comment, en juillet 2021, à la suite de plusieurs grands événements publics dans une ville du comté de Barnstable, dans le Massachusetts, 469 cas de COVID-19 ont été identifiés parmi les résidents du Massachusetts qui avaient voyagé dans la ville du 3 au 17 juillet ; 346 (74 %) sont survenus chez des personnes entièrement vaccinées. (17)

FAUX ET TROMPEUR

Selon les "responsables de la santé" du monde entier, les vaccins ne protègent personne contre l'infection, n'empêchent pas la transmission, et les gens doivent toujours porter des masques, garder leurs distances, s'isoler, être mis en quarantaine, etc. 74 % des personnes infectées lors d'une épidémie survenue au milieu de l'été ont été vaccinées. Le début des campagnes de vaccination montre également des pics dramatiques de décès. En bref : rien ne change. Pourtant, ils veulent que les injections de rappel constantes fassent partie de nos vies. L'affirmation selon laquelle "les vaccins sont sûrs et efficaces" s'avère donc fausse et trompeuse.

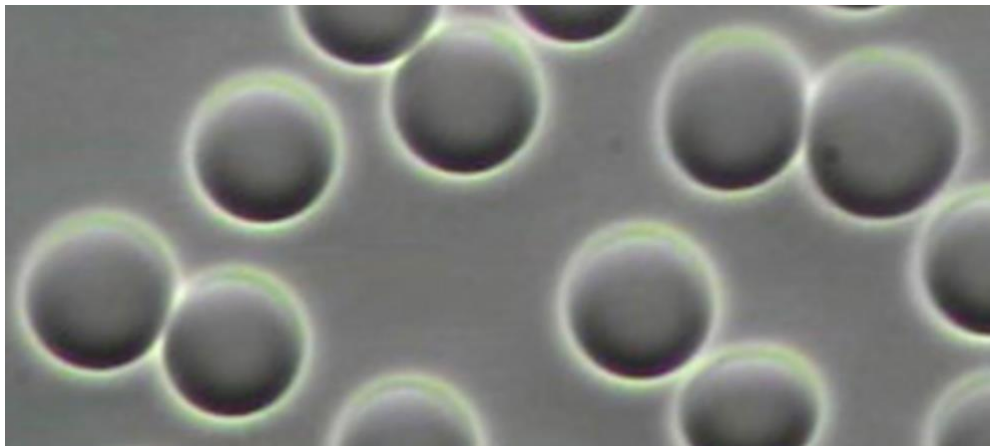

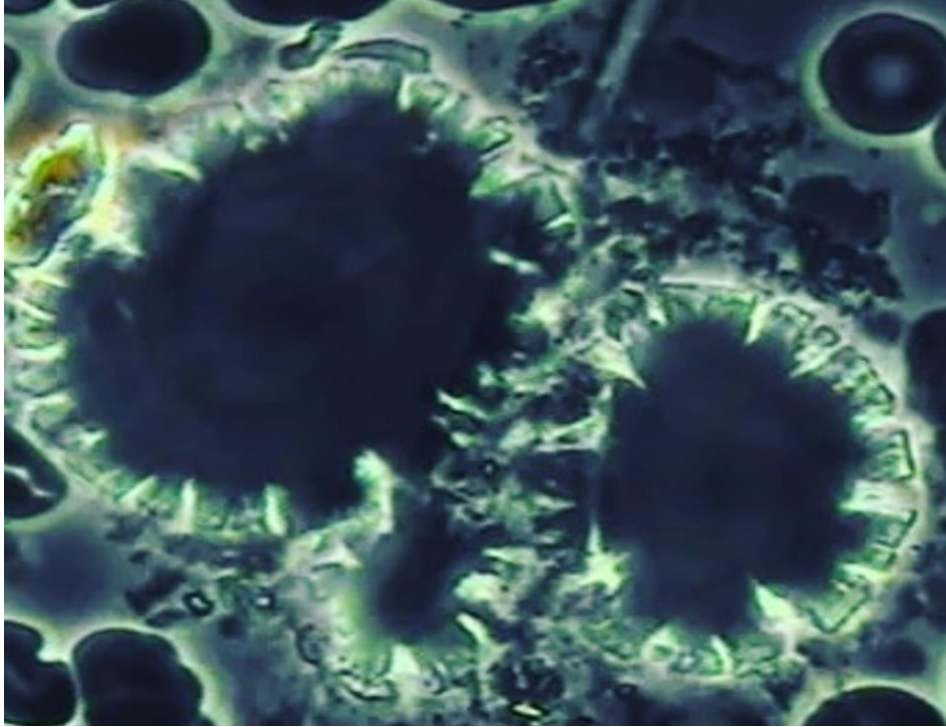
DRAMATIC BLOOD CHANGES

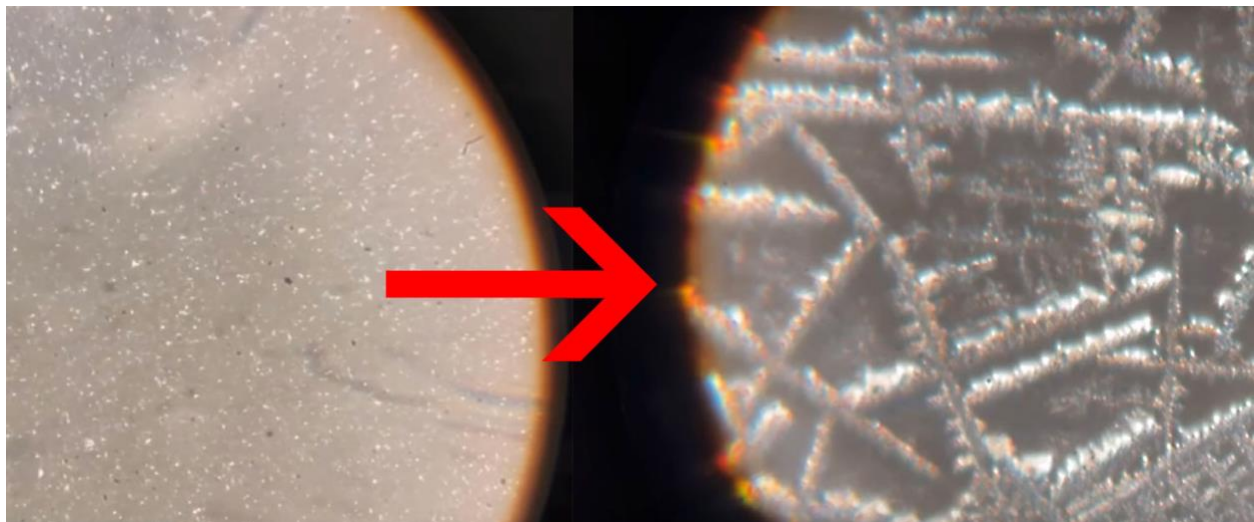

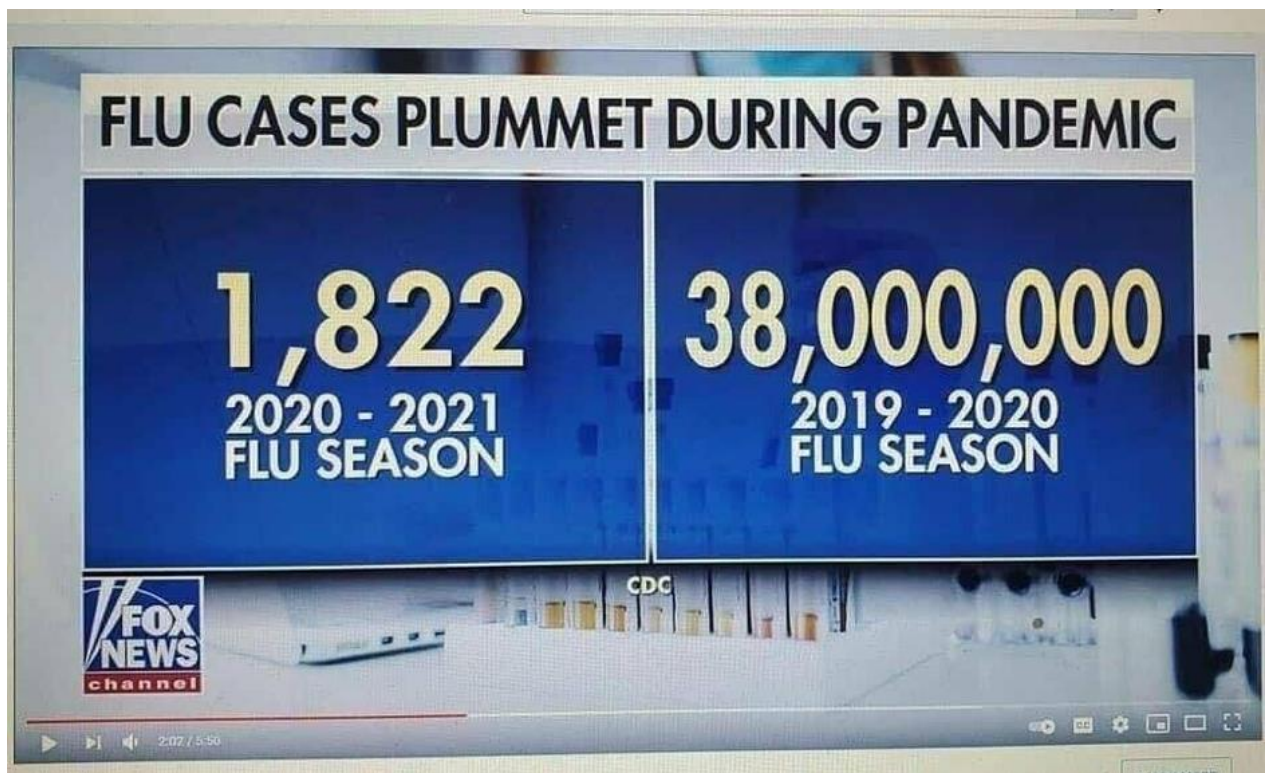
FRAUD WITH COVID DEATHS

WORLDWIDE FRAUD DRAMATICALLY INFLATED COVID DEATHS

The excuse for murdering millions of people with these extremely dangerous injections, is that it supposedly prevents people from dying from covid. The reality is however that the worldwide number of so called covid deaths is the greatest lie in history. All over the world it was revealed that over 95% of all people who were registered as covid deaths, died from other causes. The Italian politician Vittorio Sgarbi exclaimed in the Italian Chamber of Deputies:¹

'It is necessary to be united against dictatorships and to be united in the truth. Let's not make this the chamber of lies. Don't lie! Tell the truth. Don't say there's 25,000 dead. It's not true. Don't use the dead for rhetoric and terrorism. Figures from the Higher Institute of Health say 96.3% died of other diseases.'

While supposed covid deaths went through the roof, statistics in several countries showed that suddenly there are no more flu deaths. In the USA alone there are almost 40 million cases of the flu every year, but since covid hit, this number dropped to less than 2,000. Where did all the tens of millions of flu patients go? *They are now all being registered as covid.*



A forensic German coroner Prof. Dr. Klaus Püschel examined more than 140 coronadalties in Hamburg at the start of the pandemic. On German TV he said that the hysteria around the coronavirus has been gravely exaggerated. **All the people who died had underlying disorders and would have died quickly anyway, with or without the virus**, according to Püschel, adding that there is no 'killer virus'. Eighty percent of patients suffered from cardiovascular disease and the average age was 80 years. Healthy people don't have to worry, says Püschel. The coroner also predicted that corona will not even cause a peak in the annual mortality rate, a prediction which turned out to be accurate.²

A prominent newspaper in Belgium, De Tijd, discussed how the government announced that some three thousand elderly people had died of covid-19. Partly because of these figures, the entire country was placed in an extreme lockdown, with horrifying destruction as a result. However, further research showed that only 3% of the deceased had been tested. This means that **not 3,000 but only 90** people might have had covid.³

Medical professionals around the world have testified of being pressured by their supervisors to report every and all patients as covid, and register every death - no matter what the cause was - as a covid death. The internet has been flooded by thousands of testimonies of outraged people who said that they went to a doctor or hospital for issues unrelated to COVID-19 and to their amazement they were registered as a covid patient.⁴

Dr. Elke de Klerk, the founder of *Doctors for Truth* in the Netherlands, testified that she received secret messages in the dossiers of terminally ill patients, requesting that these people should be registered as covid deaths.⁵

Project Veritas called several funeral directors in New York, and they testified how every dead person was registered as covid, while everybody knew that was not correct.⁶

Minnesota senator Scott Jensen, who is also a practicing physician, revealed on Fox News that U.S. hospitals receive huge financial incentives to register patients as covid. For every person they registered as a covid death they are paid 39,000 USD. This has been confirmed by medical professionals around the world.⁷

The technical director of CNN Charlie Chester was secretly filmed by a Project Veritas undercover journalist, while he admitted that CNN inflated the death rates 'because fear sells'.⁸

A zoom meeting with African officials was leaked, revealing how they were discussing ways to ramp up covid numbers, in order to continue the lockdowns.⁹

National File has obtained a recording of a Zoom video conference call between physicians and a marketing director at Novant Health New Hanover Regional Medical Center, a group of 20 hospitals, clinics, and offices that treat patients in North Carolina and South Carolina. In the recording, Mary Rudyk, MD tells Director of Marketing Carolyn Fisher and another hospital employee that **she wants the hospitals to become more 'scary to the public' by inflating the number of COVID-19 patients**, and by using messaging that falsely tells individuals 'if you don't get vaccinated, you know you're going to die.'¹⁰

New York was the epicenter of the COVID-19 pandemic. In the heart of New York is the famous Elmhurst hospital where supposedly more people died from this virus than anywhere else in the world. It was literally the epicenter within the epicenter of the pandemic. For this reason, an experienced nurse from Florida, Erin Olszewski, decided to go there to help with the crisis. What she saw in this worldfamous hospital, however, filled her with so much horror, that she decided to take a hidden camera with her to film what was going on.

Patients who repeatedly tested negative for COVID-19 are still registered as 'confirmed COVID-19' and treated as such. They are put on a respirator in a covid ward... which causes them to die.

In a revealing documentary by Journeyman Pictures, this nurse talks about the crimes she constantly sees happening in Elmhurst. She shows on her smartphone how a patient indeed tested negative for COVID-19 twice... and yet was registered as 'confirmed' COVID-19'. FUNERAL DIRECTOR SPEAKS OUT

AN UNDERTAKER WITNESSES MASSIVE GOVERNMENT CRIMES

One very revealing eyewitness account comes from a funeral director from the UK, John O'Looney. For 10 years he was part of one of the largest funeral companies in the United Kingdom. John worked with the BBC to document what was going on with the pandemic, and closely worked with a government official appointed for the pandemic. This undertaker is connected to 45 other funeral directors, and has therefore a very clear overview of what is going on. What he discloses is shocking.

First of all he testifies that neither he or any of the other funeral directors he knows saw an increase of deaths during the so called pandemic. That was striking, as on television they constantly saw mass numbers of deaths propagated, but in the real world there was not a sign of that. He was also approached by a government pandemic official, who told him they had to label each and every death as covid. People run over by cars, heart attacks, cancer patients, it didn't matter what killed them, they all had to be labeled as covid deaths. That was a direct instruction from the government!

Once the government started mass vaccinating the British population, John says the deaths suddenly skyrocketed. 'I've never seen anything like it, as a funeral director for fifteen years. 'It's all designed to make you take the vaccine. In my network of funeral directors not a single child has died of covid. So there is no reason whatsoever to put these gene therapies into children. WORLDWIDE FRAUD

All over the world hospitals and medical staff are paid handsomely to fraudulently register all patients as covid. The hundreds of millions of flu cases every year, all over the world, are now all considered covid. Doctors are pressured by governments to register every patient as covid, and they get hidden messages requiring them to register dying patients as covid deaths. Funeral directors admit they see false covid registrations all the time, and CNN technical director Chester admitted they inflated covid numbers. ONLY THE VACCINATED DIED

DURING THE 1918 SPANISH FLU ONLY VACCINE RECIPIENTS DIED

In 1918 a disastrous number of 50 - 100 million people supposedly died of what was called the 'Spanish flu'. An expert eye witness of this event was the medical scientist Eleanor McBean, PhD, N.D. who wrote a book with her first hand experiences of what was truly going on.^{1,2} She explains there wasn't really a flu, but mass vaccinations had been imposed on the population, causing flu like symptoms, a host of different illnesses, and massive deaths.

She knew of not a single unvaccinated person who died of this alleged 'Spanish flu', while most vaccinated lost their lives.

'I was an on the spot observer of the 1918 influenza epidemic. All the doctors and people who were living at the time of the 1918 Spanish Influenza epidemic say it was the most terrible disease the world has ever had. Strong men, hale and hearty one day would be dead the next. The disease had the characteristics of the black death added to typhoid, diphtheria, pneumonia, smallpox, paralysis and all the diseases the people had been vaccinated with immediately following World War 1. Practically the entire population had been injected 'seeded' with a dozen or more diseases — or toxic serums. When all those doctor-made diseases started breaking out all at once, it was tragic. That pandemic dragged on for two years, kept alive with the addition of more poison drugs administered by the doctors who tried to suppress the symptoms.

As far as I could find out, the flu hit only the vaccinated. Those who had refused the shots escaped the flu. My family had refused all the vaccinations so we remained well all the time. We knew from the health teachings of Graham, Trail, Tilden and others, that people cannot contaminate the body with poisons without causing disease.

When the flu was at its peak, all the stores were closed as well as the schools, businesses — even the hospital, as the doctors and nurses had been vaccinated too and were down with the flu. No one was on the streets. It was like a ghost town. We [who didn't taken any vaccines] seemed to be the only family which didn't get the flu; so my parents went from house to house doing what they could to look after the sick, as it was impossible to get a doctor then. If it were possible for germs, bacteria, virus, or bacilli to cause disease, they had plenty of opportunity to attack my parents when they were spending many hours a day in the sick rooms. But they didn't get the flu and they didn't bring any germs home to attack us children and cause anything. None of our family had the flu — not even a sniffle— and it was in the winter with deep snow on the ground.

It has been said that the 1918 flu epidemic killed 20,000,000 people throughout the world. But, actually, the doctors killed them with their crude and deadly treatments and drugs. This is a harsh accusation but it is nevertheless true, judging by the success of the drugless doctors in comparison with that of the medical doctors.

While the medical men and medical hospitals were losing 33% of their flu cases, the non-medical hospitals such as BATTLE CREEK, KELLOGG and MACFADDEN'S HEALTH-RESTORIUM were getting almost 100% healings with their water cure, baths, enemas, etc., fasting and certain other simple healing methods, followed by carefully worked out diets of natural foods. One health doctor didn't lose a patient in eight years. The very successful health treatment of one of those drugless doctors who didn't lose any patients will be given in the other part of this book, titled VACCINATION CONDEMNED, to be published a little later. If the medical doctors had been as advanced as the drugless doctors, there would not have been those 20 million deaths from the medical flu treatment.

There was seven times more disease among the vaccinated soldiers than among the unvaccinated civilians, and the diseases were those they had been vaccinated against.

One soldier who had returned from overseas in 1912 told me that the army hospitals were filled with cases of infantile paralysis and he wondered why grown men should have an infant disease. Now, we know that paralysis is a common after-effect of vaccine poisoning. Those at home didn't get the paralysis until after the world-wide vaccination campaign in 1918.'

Her expert medical eye witness account was later confirmed by autopsies, that showed there indeed wasn't a flu, but the suffering was caused by random dosages of an experimental 'bacterial meningitis vaccines', which to this day, mimics flu-like symptoms. THE REAL SOLUTION: EARLY TREATMENT

If the toxic covid injections offer no solution for the COVID-19 disease, how can we then help humanity? In New York the family practitioner Dr. Vladimir Zelenko treated over 500 covid patients at the beginning of the pandemic with hydroxychloroquine + zinc + azitromycine. He also had a 100% recovery rate, with hardly any side effects, and no hospitalizations.³ As of August 2021 Dr. Zelenko and his team **successfully treated over 6,000 covid patients**. He developed a protocol to treat COVID-19 which became world famous and is saving the lives of millions of thousands of people around the world. Hundreds of studies confirm the effectiveness of HCQ in treating COVID-19 and preventing hospitalization and death. ^{5,6,7}

World leading scientists Dr. Pierre Kory and Dr. Peter McCullough are both the most published medical experts in their field. Both these physicians and their teams have successfully treated tens of thousands of covid patients using for example Ivermectin. That will be the summom of their tyranny, as they will be able to impose the desired thoughts and feelings onto the whole world, so nobody will even be able to divert from their narative anymore. 'Our graphene-brain interfaces have the capability of reading at a resolution never seen before, as well as detecting therapy-specific biomarkers and **triggering highly focal adaptive neuromodulation for increased outcomes in personalised neurological therapies.**'

It appears that the intention of INBRAIN is to merely help people with neurological disorders, but the reason I mention them is to illustrate how graphene is indeed the best substance to alter the human brain. And again, it works better with 5G than anything else. The fact that it is massively present in the covid vaccines, is therefore highly disturbing, especially if we know what the agenda is of the world leaders, as described by the Chilean president:

'5G offers the possibility that machines can read our thoughts and can even insert thoughts, insert feelings.'

Another element we have to touch on, to end this report, is the clear and public agenda of the globalists, to end humanity as we know it and steer humanity into becoming cyborgs. In reality this means nothing less than seizing all rights, freedoms and properties from the entire world population and bringing it all in the hands of the super rich.

Then there are the banking imperiums, who control all the money in the world. Their job is to bring about a cashless society where only those who are digitally connected to the system of surveillance and slavery, will still have access to finances. The Nigerian government has been paid handsomely by them, to reserve banking services strictly for the vaccinated, an example that will soon be followed by other countries.
